SANTA BENEDETTA ESTATE COOKING LESSON & WINE TASTING (separate fee)

Santa Benedetta Winery is located between the towns of Monteporzio Catone and Frascati, right on the hills where the Roman castles overlook Rome in the center of the Frascati DOC wine production region. Founded in 1650, the winery has had several owners over the years who have always taken great care in cultivating the vines and producing high-quality wines.

The winery contains a "festive reception hall" which was constructed out of an old church and turned into a lovely restaurant where they serve typical Roman dishes. Santa Benedetta Winery also offers a wonderful cooking class with wine and olive oil tasting for groups of up to thirty-five individuals to enjoy. With an assortment of recipes that have been passed down from one generation to the next, guests will prepare a pasta dish and a dessert, in the outdoor patio (weather permitting), to be enjoyed as lunch.

The perfect complement to Santa Benedetta's fantastic cuisine is that each meal is accompanied by their very own wines. Participants will learn how to select the finest regional wines in addition to the delicate theory associated with matching them with different types of food.
