- A student must register and schedule for the Full Program (all 4 parts) upon initial registration and complete the full program within an 12-month period.
- At any time within the 12-month window, a candidate enrolled in all four parts may change the course sequence or delivery method prior to the 2nd lecture of that part (Financial, Regulation, Auditing or Business). New sequence or format must begin within original 12-month window.
- **A student enrolled in the Full Program, starting one or more of the parts past the 12-month period, will be required to re-enroll as a former student and as such charged 50% of the tuition plus applicable fees for those part(s).**

An additional \$200 discount will be deducted for full program students who register within 21 days of their state selection interview.

The \$50 CDN "Find a Friend" referral check will only be issued to former Becker students registered within 12-months prior to the date of this registration.

IN CLASS REFUND POLICY

For Individual Part Students: A full tuition refund (less any applicable discounts and fees) will be issued prior to the day of the second lecture. Thereafter there will be no refund.

For Full Program Students: A full tuition refund (less any applicable discounts and fees) will be issued prior to the day of the second lecture. From the day of the second lecture and prior to the day of the fifth lecture, students will be charged full price for the part taken (plus fees) and refunded the balance. There will be no refund after the day of the fifth lecture. Student may change to a different format within 10 days of receipt of materials. After that date, no changes can be made.

Non-attendance by itself does not constitute withdrawal.

ATTENDANCE POLICIES

Attending class on different days or in a different location: If you are traveling or have missed a class, you may attend that class, one time only, at another class location. When attending in another class location merely list the location in which you are registered on the attendance sheet during class. Be sure to have the "other location" stamp and sign your personal attendance record after class. Seating may be limited.

**ONLINE & CD ADMINISTRATIVE POLICIES AND PROCEDURES
RULES FOR FULL PROGRAM DISCOUNTS**

- All students must schedule for all four parts of the course within an 12-month period upon initial registration.
- At any time within the 12-month window, a candidate enrolled in individual part may change the course sequence or delivery method prior to the 2nd lecture of that part (Financial, Regulation, Auditing or Business). New sequence or format must begin with original 12-month window.
- Any student enrolled in the full program but starting one or more of the parts past the 12-month period, will be required to re-enroll as a former student and, as such, will be charged 50% tuition plus applicable fees for those part(s).

NOTE: All CD software (Final Review, Lecture CD and Self-Study CD Course) expires 12 months after installation date.

ONLINE, CD AND FINAL REVIEW REFUND POLICY

A full tuition refund (less any applicable discounts and fees) will be issued if all materials are returned unopened in original condition within 10 days of receipt or within 10 days of the Online course start date, whichever comes last. The cost to return the materials will be the responsibility of the student. It is in the best interest of the student to ship materials by certified mail or an alternative trackable method.

After 10 days no refund will be issued. A letter explaining why the course is being dropped must accompany the materials. All students must notify Canadian Operations immediately of their decision to withdraw. Online students are also required to inform their online instructor of the same.

**ALL STUDENTS
REPEAT POLICIES**

A student may apply to qualify for Tuition Free Continuing Help (TFCH) by attending or viewing (by CD) 100% of lectures registered for and correctly completing a minimum of 90% of the applicable homework on the Course CD. In Class: Original attendance sheets and Performance Summaries are due at Central Operations, within 30 days from the last lecture of each part. If earned TFCH expires 365 days from the last lecture of the applicable part. **Online:** Lecture completion and homework documentation is to be submitted directly to the Online Instructor within 30 days following completion of the applicable part. If earned TFCH expires 365 days from the last lecture of the applicable part. **CD:** Lecture completion and homework documentation is due at Central Operations, Attn: Field Support Supervisor (TFCH), within 12 months following the date your product was shipped. If earned TFCH expires 365 days from the issue date.

Students enrolling using TFCH are responsible for materials and enrollment fees (non-refundable) upon registration. Former Becker students who have not earned TFCH are entitled to a 50% discount off the full national tuition on parts previously taken.

In the event that it is determined by an Evaluation Service, or State Accounting Board, that a student is ineligible to write the exam, and provided that full documentation is supplied to Becker Professional Review, a 90% tuition refund or TFCH eligibility to re-enroll next term under TFCH rates will be given. All said documentation must be received by Becker Professional Review within 10 days of notification from the evaluation service or state accounting board. Documentation can be faxed to 1-866-398-7375.

All refunds are contingent up on the return of all textbooks and software within 10 days of notification of withdrawal. Withdrawals will not be recognized unless made in writing and delivered in person or by certified mail, overnight mail or other form assuring proof of receipt, to the applicable metro support office. The cost to return the materials will be the responsibility of the student. Student may change to a different format within 10 days of receipt of materials. After that date, no changes can be made.

The charges for TFCH materials are non-refundable.
